GVEC to build new operations center near Marion The section of the Texas Local Government Code that covers impact fees is vague on whether political entities are required to pay impact fees, as it states Yahoo! Buzz MOST that they "may" pay the fees. The attorney general's opinion in 1993 interpreted that political entities had to pay the fee. School districts are the only political 1. Sa entities under the law exempted from paying impact fees. gather If the Attorney General's Office were to up hold its 1993 decision, Bierschwale estimated the city would have to pay CCMA 2. Sp between \$100,000 to \$150,000 in impact fees for both the public library and the recreation center. 3. Yc 4. Ac Clint Ellis, interim CCMA general manager, believes the attorney general's previous ruling on the issue is very clear. our ge "Essentially the law reads (cities) are required to pay impact fees," Ellis said. "I do believe city projects qualify for impact fees. The law clearly states political subdivisions are required to pay impact fees." 5.
